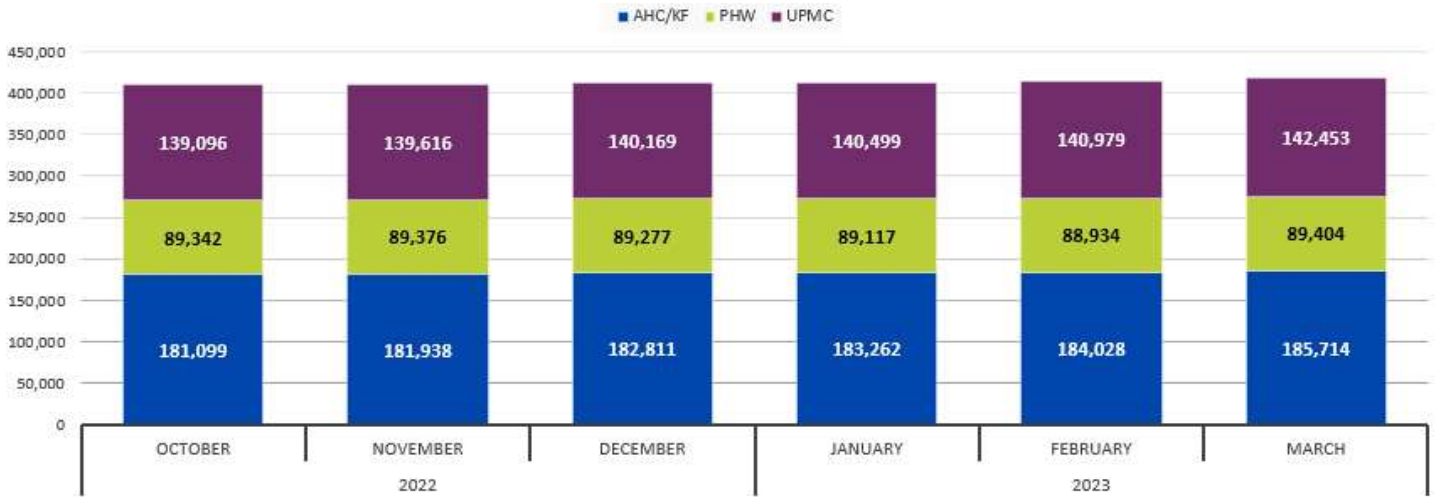

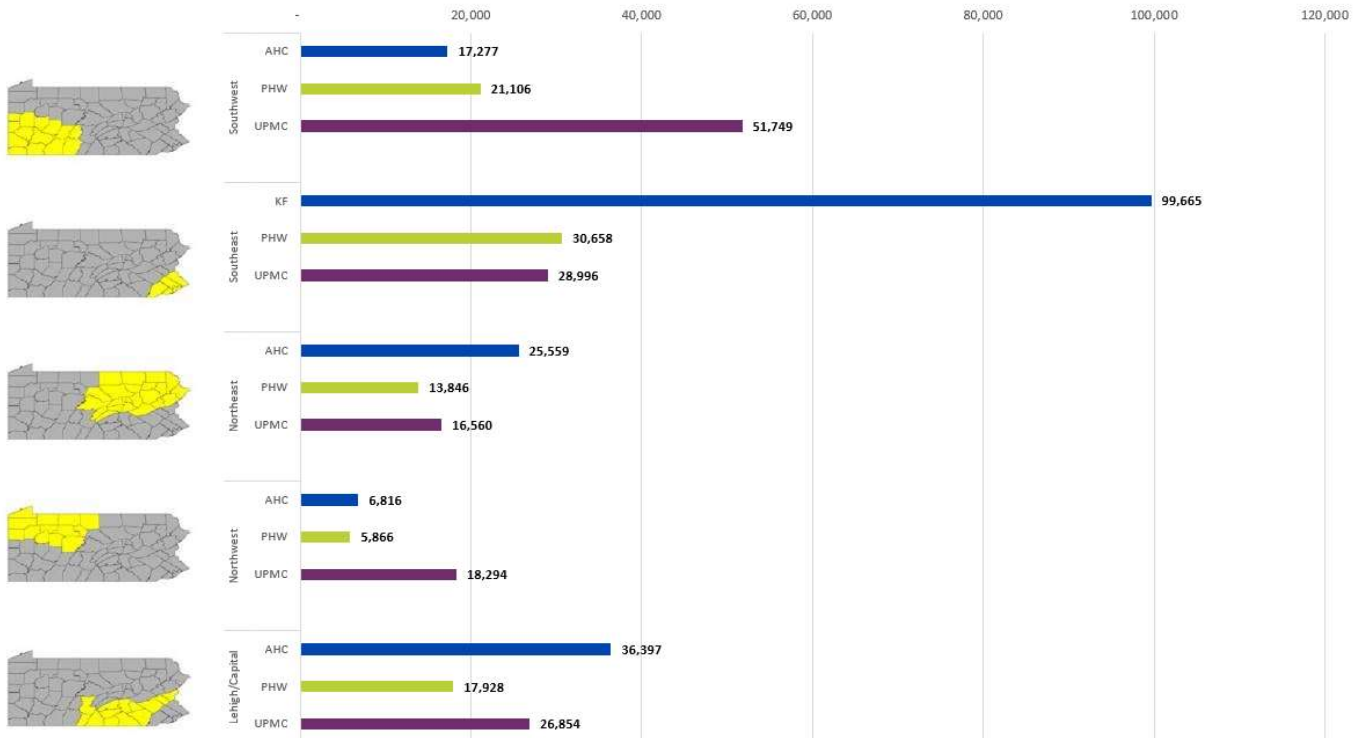
CHC Statewide Enrollments Trends by MCO

CHC Monthly Enrollment by Zone and MCO



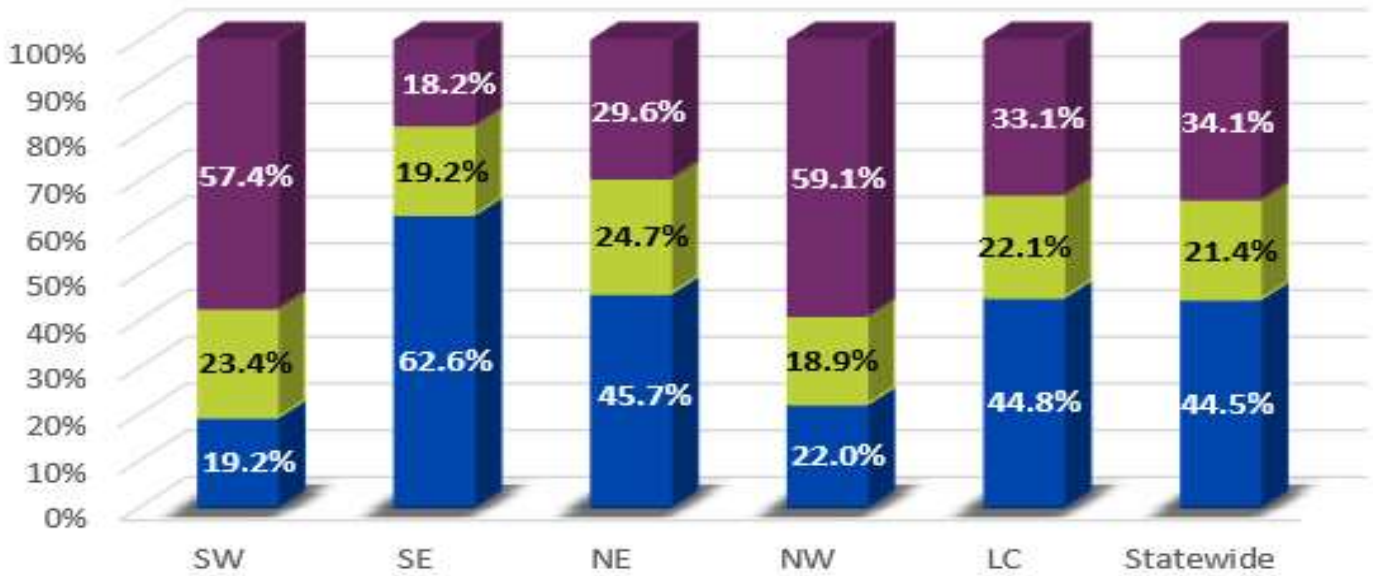

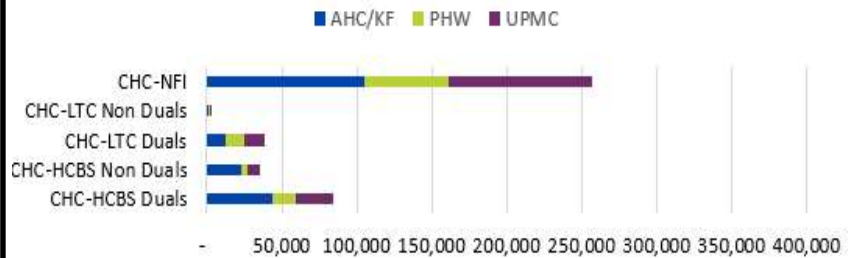

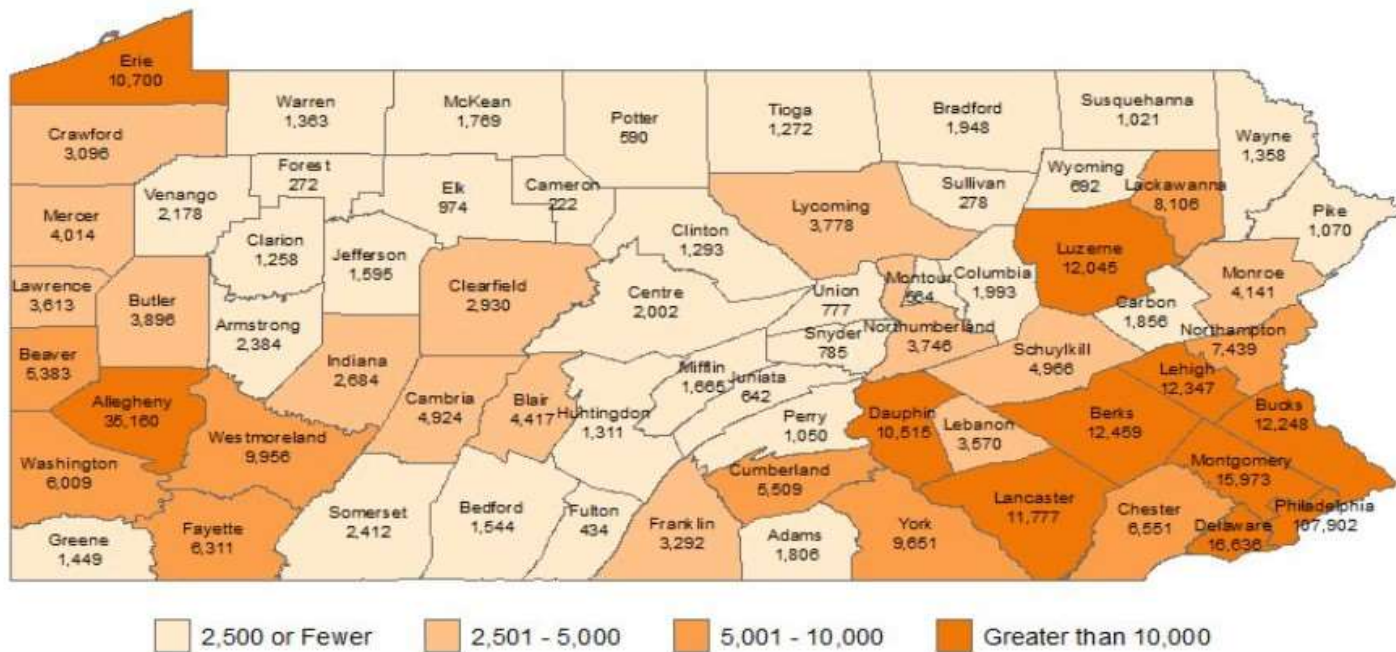

The NFI population continues to account for the majority of the population at 61.4%, this remained the same as February. The percentage of HCBS participants remained the same at 28.5%. The LTC population remained the same at 10.1% .

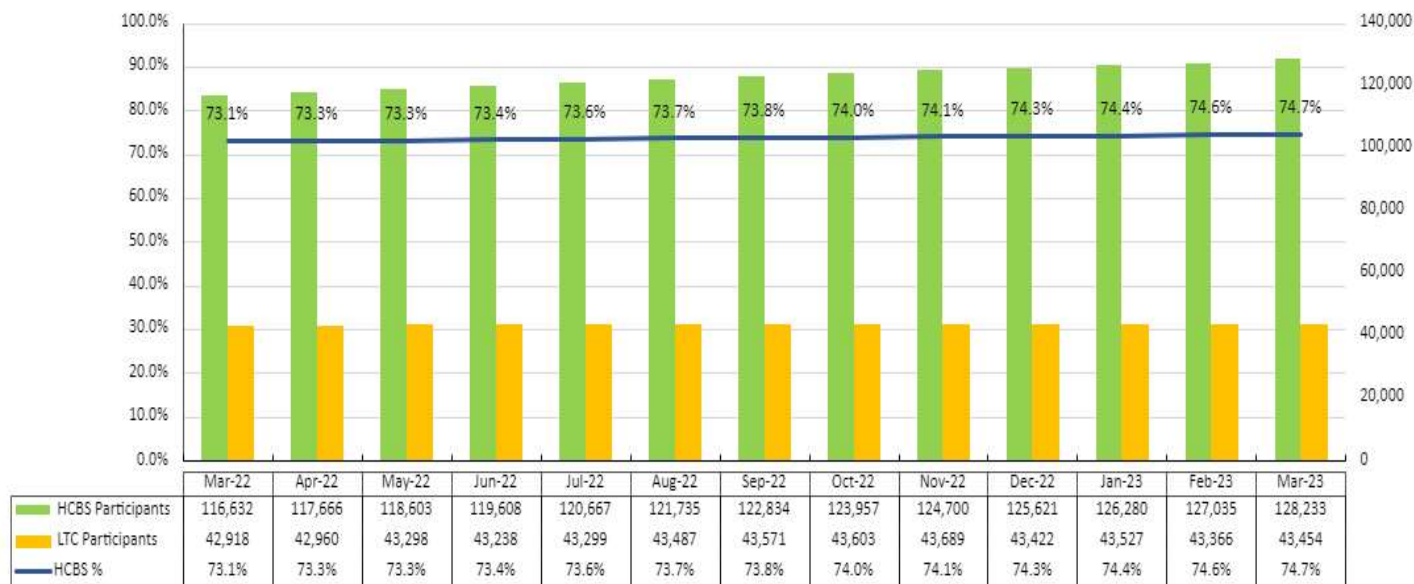
CHC Enrollments by County*

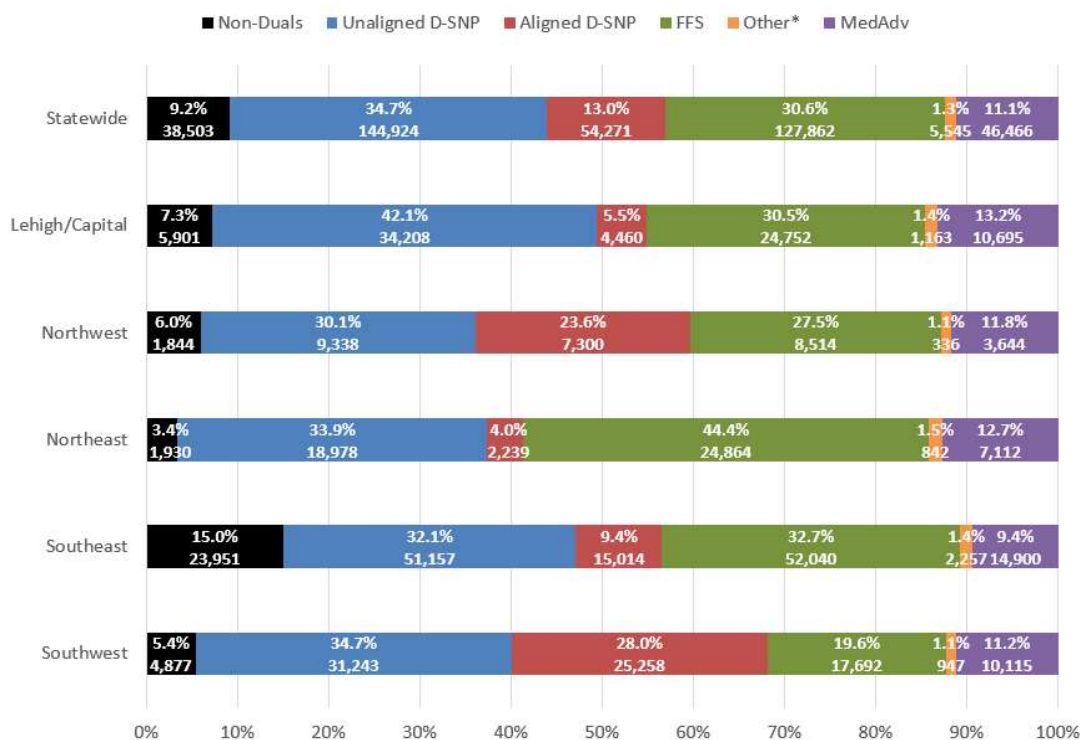
Statewide LTSS Population and HCBS Percentage

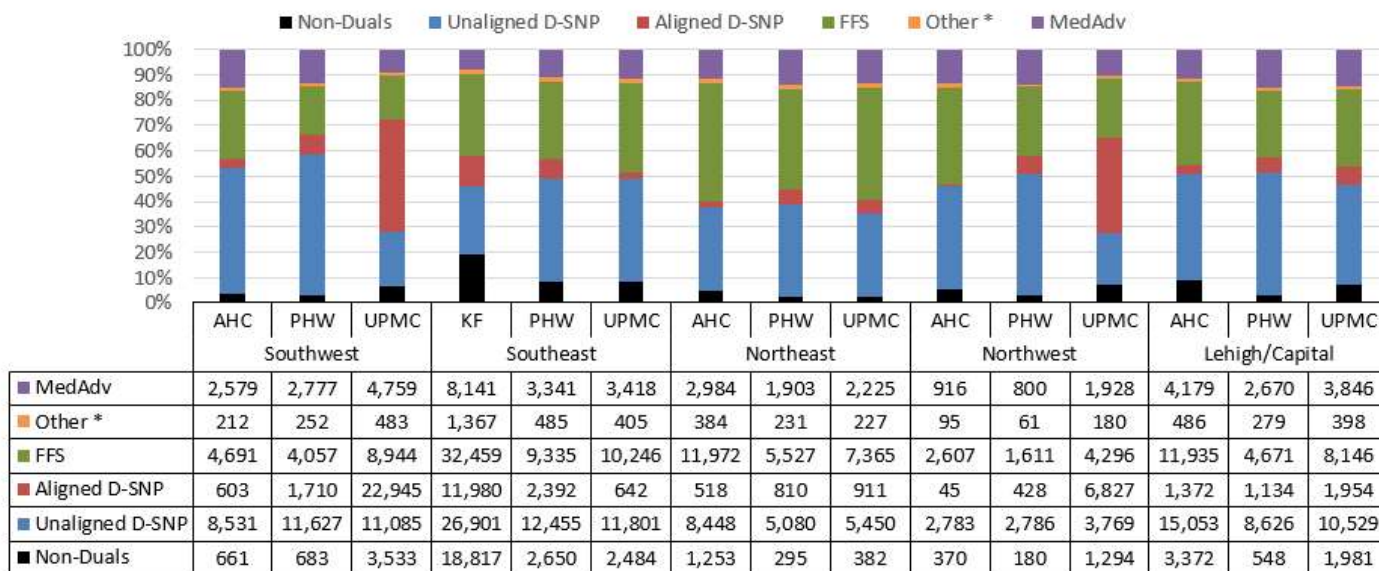
Medicare Type for All CHC Participants by Region**



In March, the statewide percentage of non-duals remained the same at 9.2%. The percentage of participants in aligned D-SNPs increased from 12.9% to 13.0%, and the percentage of participants in unaligned D-SNPs increased from 34.4% to 34.7%. The percentage of participants in FFS Medicare decreased from 31.1% to 30.6%. Other Medicare Advantage remained the same at 11.1%.

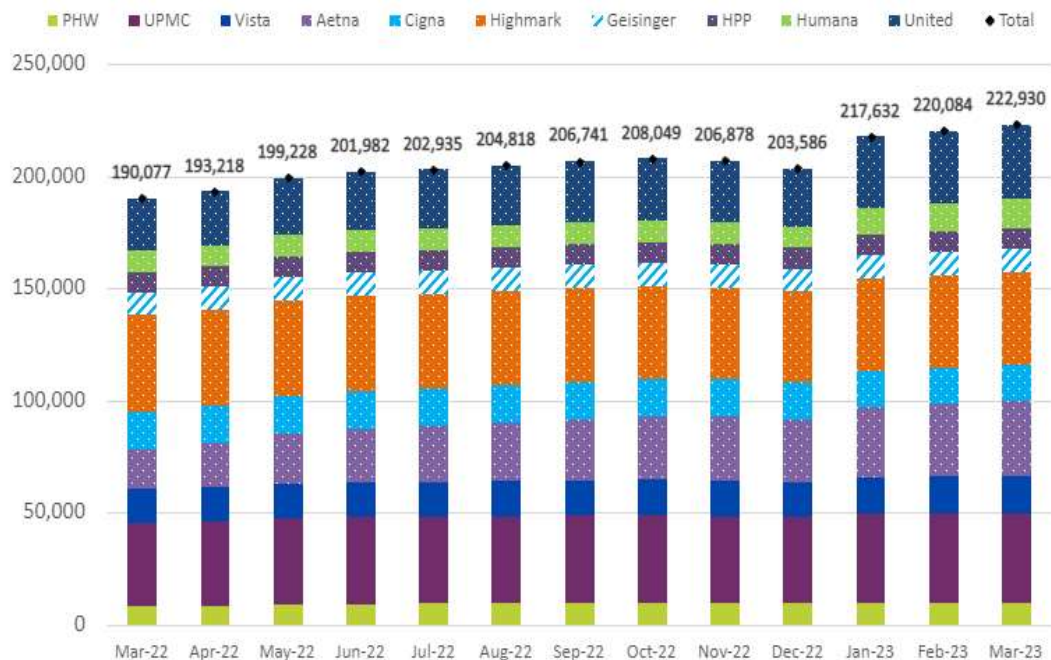

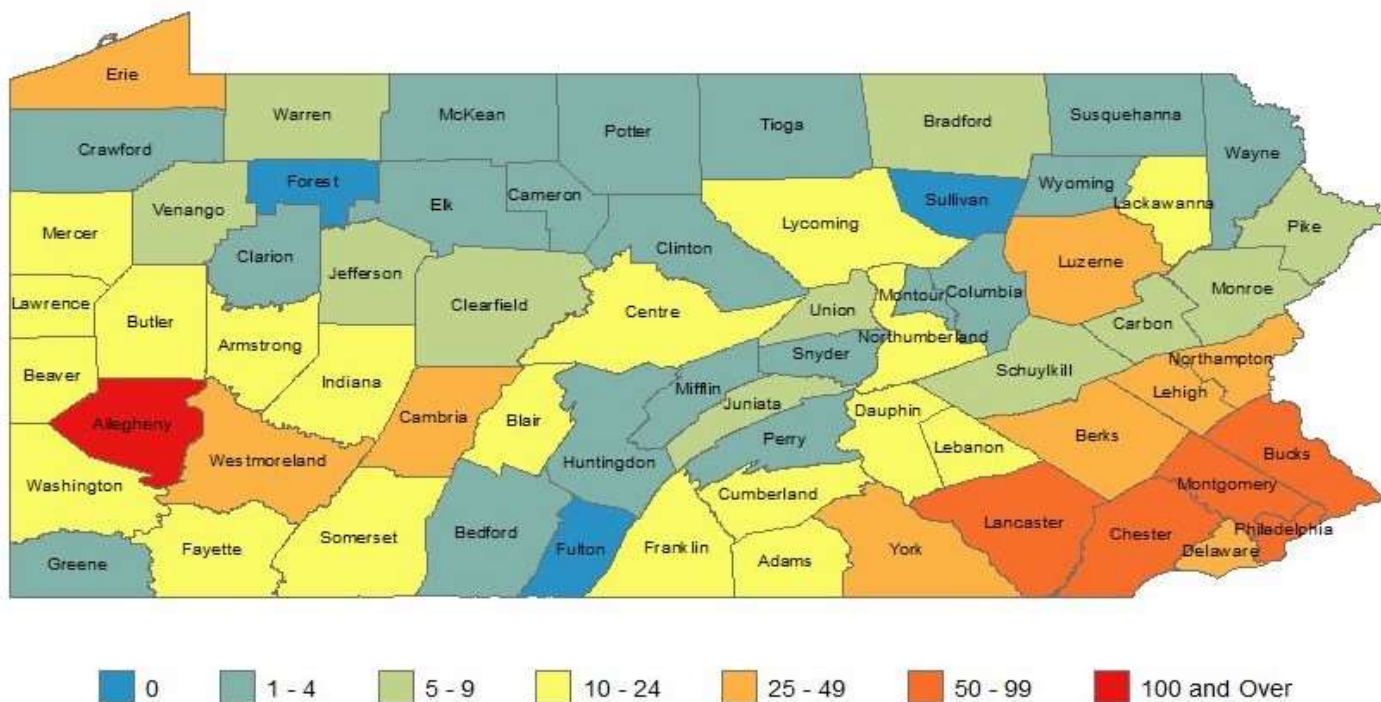
D-SNP Enrollments by Plan

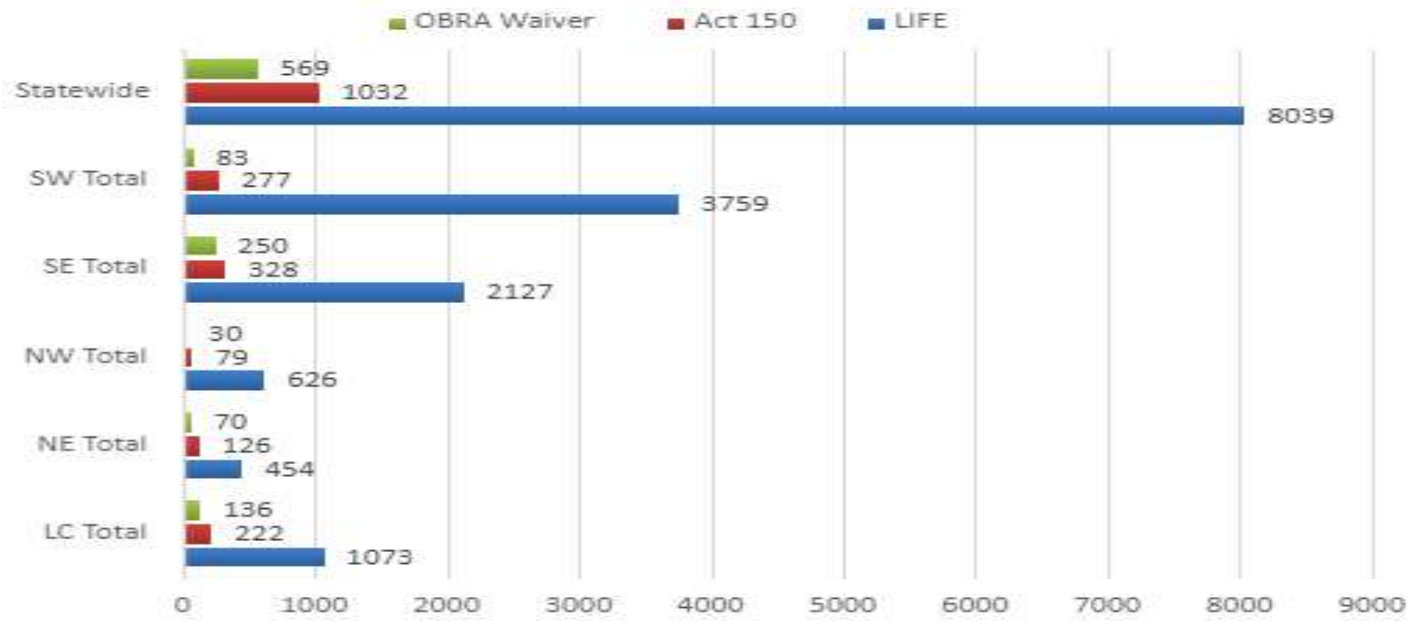

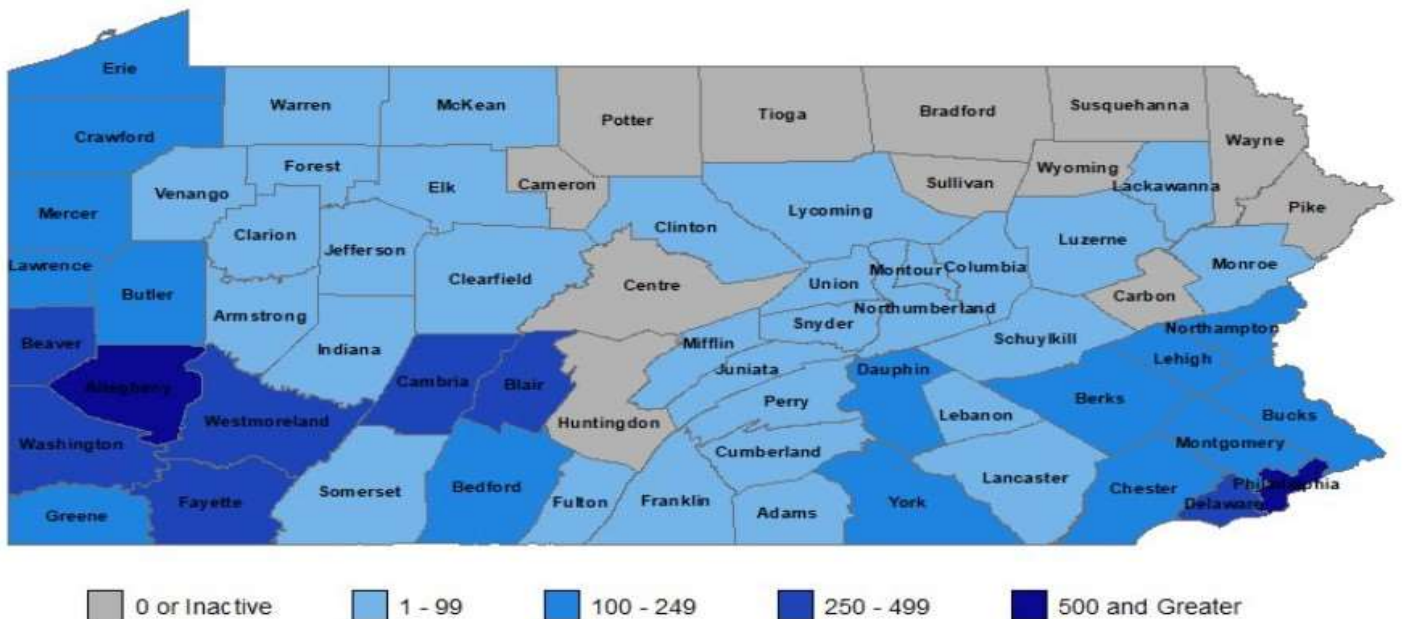
