

## **PROVIDER QUICK TIPS**



### PROMISe™ 835 Remittance Advice Companion Guide

The Department of Human Servcies (DHS) will be making a change in the values returned on the ANSI X12 835. Currently, if the claim is paid the 835 Remittance Advice (RA) response is returned with a value of "3" in the CLP02 claim status field. With this change, the 835 will return a value of 1, 2 or 3 in the CLP02 field based on how PA Medical Assistance (MA) paid the claim. This change is scheduled for implementation on July 31, 2009. The **PROMISe™** 835 RA Companion Guide will be updated closer to the implementation dates.

#### **Current Process**

Brief Description	Detail Level, Loop 2100, Segment CLP (Claim Payment Identification). Page Number: 89
Description	CLP01 will contain the Patient Control Number sent on the claim (Loop 2300, CLM01 for 837 transactions). CLP02 will contain the value '3' (Processed as Tertiary) if the claim was paid. It will contain the value '4' (Denied) if the claim was denied. It will contain the value '22' (Reversal of Previous Payment). Please see the 835 RA Companion Guide for further loops & segments

#### **New Process Effective 7/31/2009**

Brief Description	Detail Level, Loop 2100, Segment CLP (Claim Payment Identification). Page Number: 89
Description	CLP01 will contain the Patient Control Number sent on the claim (Loop 2300, CLM01 for 837 transactions).  CLP02 will contain the value "1" (Processed as Primary) if the claim was paid as primary, a "2"(processed as secondary) if claim was paid as secondary and will contain the value '3' (Processed as Tertiary) if the claim was paid as tertiary. It will contain the value '4' (Denied) if the claim was denied. It will contain the value '22' (Reversal of Previous Payment).  Please see the 835 RA Companion Guide for further loops & segments

# **PROVIDER QUICK TIPS**



The Department will also be making a change in the values returned in the 000A record. The item number will now follow the Payment number found in the TRN02. This change will make the TRN02 field match the corresponding Remittance Advice and is scheduled for implementation on July 18, 2009.

#### **Current Process**

Brief	The payment number is mapped to go into the x12 835 file as TRN02

#### **New Process Effective 7/18/2009**

Brief	The payment number and item number is mapped to go into the x12
Description	835 file as TRN02
Description	000A record contains the field payment number which is the voucher number under which that file's claims will be paid and will be followed by the item number. The payment number / item number is mapped to go into the x12 835 file as TRN02
